Hainan FTP Demonstration Project for Intl Cooperation in Green Low-Carbon Development is an international cooperation initiative led by the Hainan Provincial Party Committee and the Provincial Government. This project aligns with China's commitment to adopting international high-standard economic and trade rules and aims to establish a comprehensive, high-quality, and forward-looking partnership between China and Singapore. On January 22, 2025, Hainan Holdings and Capitaland Investment signed an agreement to jointly build Hainan FTP Demonstration Project for Intl Cooperation in Green Low-Carbon Development (Startup Area).

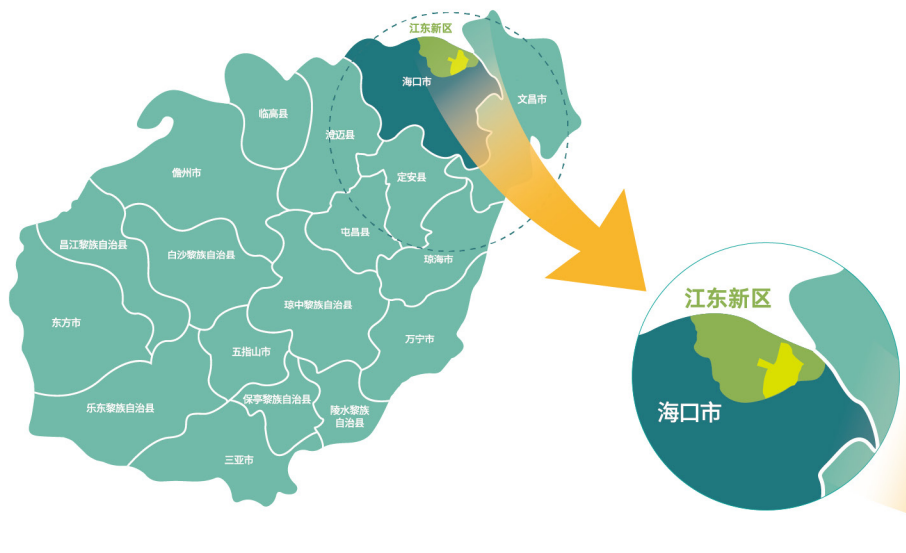

构建“3+1+1”现代产业体系

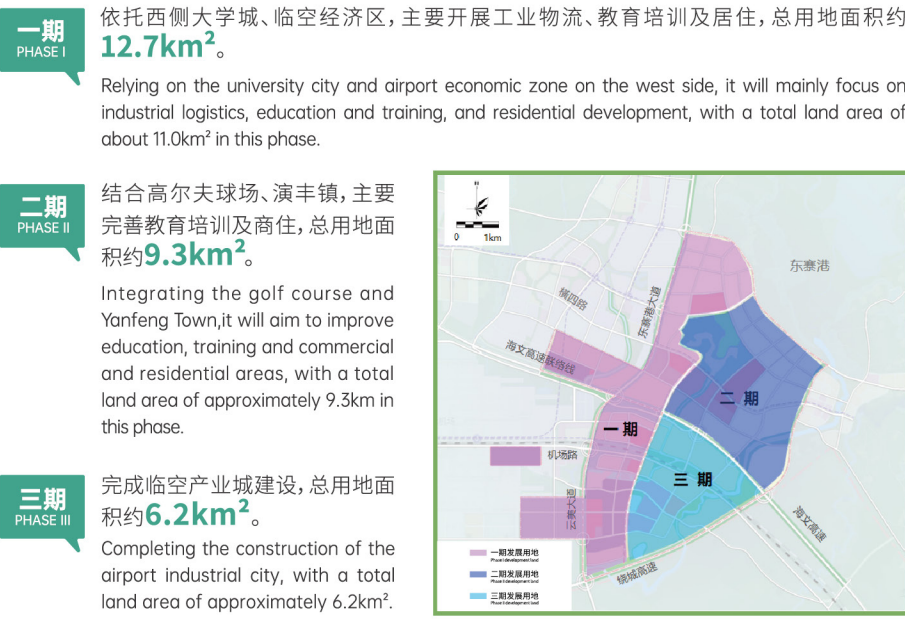
- 三大主导产业: 航空航天、新一代信息技术、高端装备制造;
